

About JetCoins

JetCoins (JET) are a new ERC-20 compliant Ethereum based token, with a fixed supply of 1,000,000 JET. JetCoins are divisible to 18 decimal places.

JetCoins serve no functional purpose, and unlike many other ERC-20 tokens are not used to fund the development of a technology project. They were created to assist their creator in learning more about Ethereum, ERC-20 tokens, and smart contracts.

Because JetCoins are an ERC-20 compliant token, they are freely tradeable via direct transfers or via smart contracts such us CryptoDerivatives.Market contracts. It is possible (although unlikely) that they could also be added to exchanges.



ICO Details

80% of the fixed 1,000,000 supply of JET are being offered via an Initial Coin Offering ("ICO"), equating to 800,000 JET. JET can be obtained in exchange for a donation at a rate of 1 JET = 0.001 ETH. To obtain JET simply donate any amount of ETH to the following JetCoins ICO contract address from an address you control, and receive back JET at the above specified rate:

DO NOT send any ETH from an exchange or from an address for which you do not control the private key. Although JET will be sent to the address, if you do not have control of the private key, then you may not be able to see or transfer the JET once they are at that address.

The ICO will be offered until all 800 ETH has been donated (and therefore all 800,000 JET have been obtained). Any ETH received through the ICO will be considered as a donation, and JET is only given as a token of acknowledgement. The amount of JET remaining can be tracked at www.jetcoins.trade

The remaining 20% of the supply (200,000 JET) are not available via the ICO and will be allocated as 8% (80,000 JET) retained by the creator of JetCoins, and 3 allocations of 4% (40,000 JET each) to be donated to various parties whose work has made JetCoins and the JetCoins ICO possible. The identities of these parties will not be made public.

ICO Terms and Conditions

- 1. By transferring Ether (ETH) to the JetCoins ICO smart contract at address 0xD766885daA0a59c1816E004FCf2506d0941D8231, the user understands that they are making a donation to the creator of JetCoins.
- 2. Any JET received as a result of donating ETH to the JetCoins ICO smart contract address are provided only as a token of appreciation and have no financial or functional value.
- 3. The user understands that while the smart contract at the address specified in point 1 is intended to issue JET at the rate of 1 JET per 0.001 ETH donated, it is possible that the smart contract may not operate as intended. The user understands that the creator of JetCoins and any other individuals involved with the deployment of the JetCoins ICO smart contract are neither responsible nor liable if the user receives a different amount of JET than expected, including if the user receives no JET at all.
- 4. This document does not constitute a prospectus of any sort, is not a solicitation for investment and does not pertain in any way to an offering of securities in any jurisdiction.
- 5. By transferring ETH to the JetCoins ICO smart contract address and/or receiving JET, no form of partnership, joint venture or any similar relationship is created between the user and the creator of JetCoins and/or any other individuals involved with the deployment of the JetCoins ICO smart contract.
- 6. Ownership of JET carries absolutely no rights express or implied.
- 7. By transferring ETH to the JetCoins ICO smart contract, the user represents and warrants that:
 - a. The user has a deep understanding of the functionality, usage, storage, transmission mechanisms and intricacies associated with cryptographic tokens, like Bitcoin (BTC) and Ether (ETH), and blockchain-based software systems;
 - b. The user has carefully reviewed the code of the smart contract located on the Ethereum blockchain at the addresses set forth under point 1 and fully understands and accepts the functions implemented therein;
 - c. The user is legally permitted to transfer ETH to the JetCoins ICO smart contract, and obtain JET in the user's jurisdiction;
 - d. The user is legally permitted to receive software and interact with the JetCoins ICO smart contract;
 - e. The user is of a sufficient age to legally obtain JET;
 - f. The user will take sole responsibility for any restrictions and risks associated with obtaining JET by the JetCoins ICO smart contract system;
 - g. The user is not submitting ETH to the JetCoins ICO smart contract to obtain JET for the purpose of speculative investment;
 - h. The user is not obtaining or using JET for any illegal purposes;
 - The user waives the right to participate in a class action lawsuit or a classwide arbitration against any entity or individual involved with JetCoins or with the creation or distribution of JET;
 - j. The user understands that submitting ETH to the JetCoins ICO smart contract to obtain JET does not involve the purchase of shares or any

- equivalent in any existing or future public or private company, corporation or other entity in any jurisdiction;
- k. The user understands and expressly accepts that there is no warranty whatsoever on JET and/or the JetCoins ICO smart contract system, expressed or implied, to the extent permitted by law, and that the smart contract system is used and JET are obtained at the sole risk of the user on an "as is" basis and without, to the extent permitted by law, any warranties of any kind, including, but not limited to, warranties of title or implied warranties, merchantability or fitness for a particular purpose;
- l. The user understands that the user has no right against any party to request any refund of the ETH submitted to the JetCoins ICO smart contract under any circumstance;
- m. The user understands that the user bears the sole responsibility to determine if the transfer of ETH to the JetCoins ICO smart contract, the obtaining, ownership, or use of JET, and/or any other action or transaction related to JET or JetCoins have tax implications for the user; by obtaining, owning or using JET, and to the extent permitted by law, the user agrees not to hold any party liable for any tax liability associated with or arising from obtaining, owning or using JET or any other action or transaction related to JetCoins.
- 8. The user acknowledges and agrees that, to the fullest extent permitted by any applicable law, the user will not hold any developers, contractors or creators of JET and/or the JetCoins ICO smart contract liable for any and all damages or injury whatsoever caused by or related to the use of, or the inability to use, JET or the JetCoins ICO smart contract under any cause or action whatsoever of any kind in any jurisdiction, including, without limitation, actions for breach of warranty, breach of contract or tort (including negligence) and that developers, contractors or creators of the JetCoins ICO smart contract and/or JET shall not be liable for any indirect, incidental, special, exemplary or consequential damages, including for loss of profits, goodwill or data, in any way whatsoever arising out of the use of, or the inability to use the JetCoins ICO smart contract and/or JET.
- 9. By obtaining, holding or using JET, and to the extent permitted by law, the user agrees not to hold any third party (including developers, contractors or creators) liable for any regulatory implications or liability associated with or arising from obtaining, owning or using JET or any other action or transaction related to JetCoins.
- 10. The user understands and accepts that the network of miners will be ultimately in control of the JetCoins ICO smart contract. The user understands that a majority of these miners could agree at any point to make changes to the official smart contract system and to run the new version of the smart contract system.
- 11. The user agrees that if any portion of these Terms is found illegal or unenforceable, in whole or in part, such provision shall, as to such jurisdiction, be ineffective solely to the extent of such determination of invalidity or unenforceability without affecting the validity or enforceability thereof in any other manner or jurisdiction and without affecting the remaining provisions of the Terms, which shall continue to be in full force and effect.
